Operating out of four locations across Toronto, Vibrant provides services to more than 3,000 clients annually, many of whom identify as seniors and persons with complex physical disabilities.

Vibrant's Board of Directors is a dedicated, committed group of volunteers with professional expertise and experience in a variety of disciplines. Currently, the Board meets six times per year to ensure effective governance of the organization.

There is also a committee structure consisting of:

- Internal Affairs (Finance, Human Resources, and Quality and Risk)
- Governance and Nominations
- Resource Development and Communications.

These committees, comprised of both Board and community members, assist the Board to support the Chief Executive Officer in leading organizational operations.

The Board of Directors meet both in person at Vibrant's Anne Johnston Health Station site at 2398 Yonge Street (north of Yonge and Eglinton) and virtually.

Time commitment, depending on the committee meeting schedule, is three to six hours per month.

We are currently seeking individuals to fill three upcoming vacancies on the Board of Directors and are searching for residents of the GTA who share our passion for the mission, vision, and values of Vibrant.

Specifically, we are looking for people who have the following:

- Previous experience serving on a not-for-profit Board of Directors;
